PRESIDENTS MESSAGE

Fall is the time of year when we typically get out and monitor rangelands. It's a great opportunity to take a close look at rangelands with a team of old and new acquaintances. I think we all learn something new when we go to the field, collect data, and discuss range ecology and management.

While many areas of Arizona received appreciable summer rain, the U.S. Drought Monitor of August 31 shows that much of northern and central Arizona is still in an extreme drought. However, much of Pima and Santa Cruz counties are rated only as abnormally dry (the least intense of the drought intensity classifications). I bring this up because those fortunate enough to attend our summer meeting August 19 and 20 saw this part of the state first hand. It was my first trip to Santa Cruz County borderlands and I was completely taken by the beauty and productivity of the area.

Brown Power Productions L.L.C. (Dean Fish, Dan Bell, and Emilio Carrillo with help from Byron Lambeth) hosted and catered the summer meeting at the Bear Valley Ranch Headquarters. About 50 or so members and presenters attended the meeting. Several presenters shared their experiences and challenges as they balance law enforcement issues with natural resource management objectives. Dean Fish has provided a more detailed report on the summer meeting in this issue. Thanks to the Bell Family for hosting this excellent meeting.

At the summer meeting, we had many familiar faces (the usual suspects). We also had some new faces: Lee Fitzhugh and his wife Flora. They have recently retired to eastern Arizona. Lee was an Extension Wildlife Specialist with the University of California Cooperative Extension, but has spent lots of time in Arizona (Lee got his PhD from the U of A in 1974). I hope we didn't scare them off with our exuberant festivities (see Dean Fish's recap of the Chubby Bunny Contest in this issue).

The 2005 Arizona Section Winter Meeting is tentatively planned for January 6 and 7. The location is still up in the air, but we discussed Camp Verde, Maricopa, Casa Grande, and Phoenix. The general membership also provided input for the topic that seems to be leaning toward Using Technology in Range Management. Some of the suggested subtopics were the use of technology as it relates to Rangelands West, RangeView, Fecal Analysis, Financial Planning, Ecological Site State and Transition, and Animal Behavior. Dean Fish is synthesizing this input to assemble another first class meeting.

Arizona Section Awards Chairman, Emilio Carrillo, is soliciting nominations for Range Manager of the Year, Professional and Technical Guidance, Outstanding Service, and Outstanding Young Professional. It is up to our section membership to nominate outstanding individuals and/or families to receive these awards. In this issue, Emilio has included details about the awards and the process. 2004 SUMMER MEETING UPDATE Borderlands: Implications to Natural Resource Management

The stage was set in San Carlos last January for the leadership of the Arizona Section to discuss topics related to border issues at the 2004 summer meeting. Taking this to heart, the Board of Directors (with help from several members) put together an informational and fun event that will not soon be erased from the memories of the attendees. The setting was the historic and scenic Bear Valley Ranch west of Nogales, Arizona. While the monsoon moisture had mainly missed this particular piece of country, the keen attention to proper range management was easily observed by participants.

Over 50 people attended the meeting, which began with Dan Bell welcoming guests, and detailing some of the history and current challenges he faces as a borderlands rancher. Following his presentation, Keith Graves, District Ranger, Nogales gave a Forest Service perspective, followed by Jeff Zadareky, US Border Patrol. Both gave very informative presentations on the real issues that they face every day and this led to much discussion on potential solutions that would help natural resource managers on the ground. Ross Humphreys, who ranches in the Altar and San Rafael Valleys, gave his insight into the unique challenges ranching on the border poses to his operations and sustainability. Following a break, the group shifted gears and heard from Doug Duncan, US Fish and Wildlife Service, Doug Saunders, NRCS-Sells, and Gabriel Paz, Arizona Game and Fish for agency points of view. All gave great insight into policy and other current issues on the border. A highlight was Gab removing a rattlesnake from Kristen Egen's seat during one presentation. Following the formal presentations, the group headed to view a house that had been burned down by undocumented aliens and the historic Yaqui Trail Corridor.

Meeting participants returned to the headquarters and immediately smelled the distinctive odor of a mesquite fire. Brown Power Productions, LLC was in the midst of preparing a steak dinner for the evening meal. Many thanks go to all of the help in preparing the meal and a special thank you to ZZ Cattle Company and Anchor F Land and Cattle Company for sponsoring the sweet corn. A highlight for many was Bill and Posy Piper's delicious Dutch oven cobbler. Following dinner, guests were treated to an exciting presentation from Jack Childs on the borderland jaguars. It's time again to start submitting nominations for our section. This is an excellent opportunity to recognize all the hard work and great stewardship throughout our diverse state. The awards categories focus on the high levels of progress made in various land management practices. For an individual to be nominated for an award gives that person much deserved recognition as well as positive publicity for the Society and the ranching industry overall. The four award categories are:

RANGE MANAGER OF THE YEAR: Recognized for progress in the planning, application, maintenance, and improvement of range condition through the use of grazing management practices for proper use and distribution of grazing, installation of range improvements, control of undesirable plants, seeding of rangeland, control of erosion, and husbandry and breeding of livestock. Participation in community and State citizenship activities and cooperation with State and Federal agencies in management of the land for grazing and other uses is also recognized.

AWARDS FOR PROFESSIONAL AND TECHNICAL GUIDANCE: A person or persons with range management or range conservation expertise and education, but not ranch owners or operators, may be selected and honored for their contribution to excellence in grazing management. Such persons may be employees of Federal or State agencies or universities, other government agencies, or individuals operating independently or as members of agricultural firms.

. **OUTSTANDING SERVICE AWARDS**: A person not limited to Society membership, and not limited to residence in Arizona may be nominated for an Outstanding Service Award by any member of the Arizona Section of the Society for Range Management. Such nominations will be made to the board of Directors prior to the end of the calendar year.

OUTSTANDING YOUNG RANGE PROFESSIONAL AWARD: This award requires SRM membership and recognizes superior performance and leadership potential in any range-related area. Nominee must be less than 40 years old on January 1, 2005. If you are aware of a young range professional that you feel deserves of this award please send in your nomination!! This is an excellent opportunity to give a hard-working individual some great recognition.

NATURAL RESOURCES CONSERVATION WORKSHOP FOR ARIZONA YOUTH 2004

FINALLY, the thirty-second Natural Resources Conservation Workshop for Arizona Youth, sponsored by the Arizona Section Society for Range Management, was held at St. Joseph's Youth Camp in Mormon Lake, AZ. The workshop, open to all high school students in Arizona, commenced with the arrival of twenty high school students at on August 2nd.

Various specialists presented a series of workshops each day; campers participated in field trips that addressed issues in soil and water analysis, rangeland monitoring, plant and wildlife identification, and forestry. In addition to the field trips there were lecture presentations on water supplies, drought analysis and impact, and weather forecasting and the dependence of many agencies on those forecasts from air traffic controllers to farmers to firefighters. In addition to the lectures and field trips, there was "hands-on-instruction" in the use of compasses and the Global Positioning System (GPS).

Evening presentations included: a Native American viewpoint of the ecosystem; an overview of the galaxies followed by actual star gazing through three professional telescopes brought to the campsite by the Flagstaff Astronomy Club; a short hike to view a herd of elk passing nearby on Mormon Lake; and a tour of the U of A's V-Bar-V cattle ranch followed by a fabulous steak dinner complete with cherry cobbler baked in Dutch ovens

In summary, 20 high school girls and boys participated in this workshop taught by no less than 20 different specialists from different agencies and schools. On the last night the staff voted on the Outstanding Workshop Participant which included an evaluation not only of the quality of their participation but on the thoughtfulness expressed in the journals which they had to write and hand in. This honor was given to **Mark Saraficio** of Sells, AZ. He will be given the opportunity to attend the SRM meeting in Texas. The runner up was **Akilah Graham** from Vail; she will be given the opportunity to attend the AACD meeting in Phoenix.

All in all, it was a great educational experience for these 20 students. The dedication and commitment of the staff and counselors (Travis Nauman & Alisha Phipps) combined to make this an outstanding event.
