# **Director North Report**

Hi Everyone. I'm Christopher Bernau, the Director North with Joelle Acton. First I'd like to take a moment to thank everyone for giving me the opportunity to be Director North. It has been fun, with lots to do and much to plan. We've already had our Director North Spring Field tour and are now working towards our summer meeting in Prescott.

That 2015 Director North Spring Tour was on Friday May 8<sup>th</sup> and was a great success. We had it at Anita Waite's Cane Springs Ranch; located along state highway 93, south of I-40 a few good miles. The day was windy and slightly overcast; so a beautiful day for a field tour. The vegetation was mostly desert grassland with encroaching junipers at the higher elevations.



Chris Lowman of the Arizona State Land Department talked about the history of management

before Anita bought it. Like a lot of Arizona, much of the land was heavily and continuously grazed until the 1934 Taylor Grazing act. After that the landscape saw management changes that included an increasing number of fences, segmenting large pastures into several smaller pastures, and various rangeland improvements. The general grazing strategy changed over time, but seemed to include some rotation, with the mountainous pastures mostly continuously grazed due to the difficulty of moving animals in and out of that terrain.

Anita talked about her management of the ranch and the changes she has made over the years. Much of that was more water, putting in deeper wells, and maintaining a rotational grazing system. One interesting management technique is that the cows are herded by helicopter in those difficult mountainous areas. It seems a helicopter can get over 90% of the cows out of the pasture in a single day when it takes several cowboys over a week to do it manually; so it is cost effective.

We visited three key areas where Mike Blanton of the Kingman BLM office described the monitoring program and the changes in vegetation on the ranch under different management techniques. Since Anita there has been a steady upward trend in vegetation, with both an increase in density of grasses and forbs as well as an increase in plant diversity. This improvement has been recognized and

Anita has been the recipient of several rangeland management awards including the 2008 Range Manager of the Year award from the AZSRM.

That's the gist of the field tour. We had 18 people show up representing a wide variety of backgrounds such as the BLM, BIA, UofA, AZGFD, Arizona State Land Department, Diablo Trust, Ranchers, and others; including the national Society for Range Management's very own Vice President, Dr. Larry Howery! We even had all the AZSRM Directors present for a great group photo. We were all very excited about this field tour, but John Hall was especially drawn to it.

# SECTION AWARDS TIME!



It is time to start considering and penciling down all those people who give **Outstanding Service**, who are exceptionally **Young and Professional**, and provide **Outstanding Professional and Technical Guidance**. Also, who could leave out an opportunity to nominate a commendable Range Manager for our 2015 **Range Manager of the Year**. Remember, just because this award is presented at our 2015/16 meeting, their outstanding actions can span recent years. Just think, it is always nice to receive compliments for a good job well done. Don't fret; not all nominees have to be Society members!

For **Outstanding Service**, that person must make significant advances and contributions to the art and science of range management in Arizona. This person should be pretty outstanding!

A **Young Professional** award nominee must be *under 40 years of age*, who *contribute to betterment of range management* throughout Arizona. Someone who works with 4H, or helps coordinate weed pulling events, or are asked to speak at a meeting. Any number of contributions would make a great nominee. Do you know a new young rancher or farmer who is ecologically minded, or a local 4H'er who has gone to Nationals, or a student who is a president of a local college chapter? Let's promote our young professionals.

Someone who is nominated for a **Professional and Technical** award can't be a rancher, or manager (save those people for our Range Manager award) but other individuals that are actively engaged in a professional field dealing with range management such as teaching, research, advice and counseling, technical assistance, or providing information via print or electronic media. These people are often behind the scenes, and need encouragement like everyone else.

A Range Manager of the Year is a rancher or manager of a livestock operation that contributes to the art and science of range management (sense a theme). Do you know someone that is testing new or unusual methods, provides leadership, and worthy of special merit? If so, nominate these individuals. Over the last year, drought has become a talking point among Arizonians. Do you know anyone who is planning for the drought or taking charge of a group to discuss this issue?

Just take one day, and think about those you enjoy interacting with, someone who you feel confident in, or enjoying having a cup of coffee with. What about those individuals make you feel good, I bet those are the types of people who should nominate. Arizona is a big state and there are endless opportunities. Send them my way!

Of course there are more to these short descriptions, so contact me and start the nomination process for a worthy individual. Once you have nomination forms, fill them out in entirety, sleep on it (literally) and add to it later. These nomination forms are the life blood of our committee.


