Student Scholarship Recipients Recognized at the Section Annual Meeting

At the Annual Meeting in San Carlos on January 12, 2004, the recipients of the Sections Outstanding Undergraduate Student Scholarship were recognized from Arizona State University and the University of Arizona. The scholarship recognizes the outstanding student in a degree program emphasizing rangeland management. Each recipient receives a check for \$300, and a one-year membership in the Society for Range Management.

The recipient from Arizona State University was Derek Stauffer. Mr. Stauffer is currently the President of the Student Chapter. He will graduate in May 2004 with a degree in Applied Biological Sciences with an emphasis in Wildlife Habitat Management. His career goals include research and education in natural resources with emphasis on the rangelands of the southwestern United States. He is currently employed as a Research Assistant on two projects led by Arizona State University faculty: biogeochemical processes of natural and unnatural riparian systems, and ecological restoration in riparian and dryland conditions.

The recipient from the University of Arizona was Joe Harris. Mr. Harris is currently the President of the Student Chapter called Tierra Seca. In that capacity, he has stimulated great interest among his fellow students to participate in the Plant Identification and Range Management Exam at the Annual Meeting of the Society for Range Management in Salt Lake City. He grew up on a ranch near Double Adobe (north of Douglas). Currently, he is in the Student Career Experience Program with the Natural Resource Conservation Service (NRCS), where he is learning all he can from Dan Robinett. Mr. Harris hopes to work for the NRCS when he finishes his degree.

On a related topic, Amy Tendick was the recipient of the Marcelle E. Schmutz Memorial Scholarship given in memory of Erv Schmutz's father. Erv was a longtime faculty member in Range Management at UA. Ms. Tendick is a senior earning a Bachelor of Science degree in Wildlife, Watershed, and Rangeland Resources with emphasis in Rangeland Science and Management. She was the recipient of the Arizona Section Scholarship last year. Her career goals are to gain experience in work related to natural resources management and work for a federal agency or non-governmental organization.

Upcoming Arizona Section Meetings

The Arizona Section awarded its Range Manager of the Year Award to Beatrice Zueger and Chuck Lange of the X-One Ranch. The X – One is located between Seligman and Kingman near Hackberry on State Route 66 straddling Mohave and Yavapai counties. The ranch consists of mixed ownership comprised of BLM, State lands, and private lands. Beatrice and Charles are advocates of on the ground management and getting all parties involved in the planning process. A coordinated management plan between the BLM, Arizona State Land Dept., University of Arizona Mohave County Cooperative Extension, Big Sandy Natural Resource Conservation District and the Natural Resources Conservation Service has been developed. They have demonstrated sound practices to control erosion such as brush structures to stop head cutting on gullies using juniper. At the same time, they have cut juniper to control encroachment on large areas of open grasslands that occur through the ranch.

Long term vegetation monitoring transects have been established to record range health and trend on the ranch. Although Arizona has suffered from drought for many years, the X – One monitoring data shows the ranch ecological sites are stable or are in an upward trend. Other improvements include many miles of pipeline, numerous earthen water tanks (ponds) and over 150 miles of fencing. Beatrice and Charles have been conscience stewards of the land. The X – One ranch is deserving of the honorary award of the Arizona Section of the Society for Management Range Manager of the Year. Congratulations Beatrice and Chuck!!

BLM PROPOSED GRAZING REGULATION REVISIONS

In December of 2003, the Bureau of Land Management (BLM) proposed to revise its regulations concerning the administration of livestock grazing on public lands. The BLM believes that these revisions are needed to "advance BLM's goal of promoting cooperation to achieve rangeland management objectives." In the Executive Summary to the EIS for the proposed revisions, the BLM stated that the regulatory revisions focus on improving working relations with permittees and lessees, protecting the health of the rangelands, and increasing administrative efficiency and effectiveness. In addition, the revisions are intended to resolve several legal issues. Several public meetings were held including one in in Phoenix on January 28th and one in Salt Lake City on January 27th, which was attended by members of the Arizona Section. For more information go to www.blm.gov/grazing. The following table illustrates the proposed changes and the BLM's reasoning for the proposed change:

SUMMARY OF REGULATION CHANGE	REASON
Modify definition of preference and active use and remove definition of permitted use.	Provide assurance to operators regarding forage amounts upon which they may rely. Clarifies confusion over introduction of "permitted use" term.
Allow shared title to range improvements.	Recognizes and promotes permittee investment.
Phase-in changes in active use over 5 years if change is greater than 10%.	Provide BLM and permittees opportunities to adjust; allows opportunity to monitor increases or decreases in use.
Require monitoring and assessment as basis for land health determinations.	Emphasizes the use of data and analysis to support decisions; emphasizes vegetation community trends rather than one time observations.
Extended timeframe following S&G determinations for development of appropriate grazing management action.	Allows a realistic time period for response (24 months) and to accomplish legally required processes.
Reduce requirements for interested public involvement in day-to-day grazing management matters.	Focuses interested public involvement on planning rather than day-to-day operations. Allows managers flexibility to respond more quickly when additional process provides little benefit.
Emphasize CCC on biological assessments and clarify document purpose.	Improves consistency on CCC and clarifies difference between a decision and a supporting analysis document.
Establish new service charge amounts.	Updates service charges; current service charge is only \$10 for crossing permits, preference transfers and replacement or supplemental billings.
Remove requirement for livestock water right to be held solely in U.S. name.	Allows flexibility to work with State processes; with site- specific situations.
Clarify prohibited acts tie to a specific permit or lease.	Clarifies nexus between prohibited act and grazing authorization.
