By this time last year, several unwanted wildfires had already consumed several thousand acres of forest and rangeland with the most catastrophic fire and bark beetle outbreak in Arizona's recorded history just over the horizon. Whether it was dumb luck or good planning, we were also in the process of putting the final touches on our summer meeting agenda with the theme, "Ecological Restoration in the Southwest Ponderosa Pine Forests." Two years ago, we gathered in the cool pines near Mormon Lake to discuss water conservation, range, and watershed issues in Arizona. At our most recent board meeting in Prescott, the board finalized the agenda for this summer's meeting with the theme, "Making Science-Based Rangeland Management Decisions Following Drought." This summer's meeting will follow several extremely dry years in Arizona. I hope you have taken advantage of our section's forward-thinking by attending as many of these programs as possible.

Ranch and livestock managers and federal rangeland managers will be presenting their thoughts on how to plan in advance for drought management in the southwest. We have also invited Dale Bosworth, Chief of the United States Forest Service to join us. Chief Bosworth is a member of SRM and is tentatively scheduled to be in Arizona around the time of the summer meeting. A cookout is being planned by several of our board members. If you attended the last few summer meetings, you already know the food and impromptu entertainment will be great! It should be a fantastic time to once again spend some time together in the cool pines.

At our general business meeting in August, we will discuss many things, including our membership drive. In the March newsletter, I issued a challenge to each of you to recruit at least one new member before our winter section meeting in 2004. How are you doing? Have you taken this challenge seriously? If not, PLEASE think about someone you know who is currently not a member of SRM but should be. HEADS UP! It's time to start thinking about nominations for this year's awards! Nominations will be received for the following awards:

1. RANGE MANAGER OF THE YEAR: May be selected by the Awards Committee from owner-operators and ranch mangers who have been nominated by the County Committees. The recipient shall be honored at the Annual Meeting and shall receive a plaque commemorating the award. The recipient need not be a member of the Society for Range Management; must be owner-operator or manger of a working ranch unit; must not have received this award within the previous six years; and cannot be a member of the State or County Awards committee or the Board of Directors.

Primary criteria used for selection of the recipient shall include progress in the planning, application, maintenance, and improvement of range conditions through the use of grazing management practices for proper use and distribution of grazing, installation of range improvements, control of undesirable plants, seeding of rangeland, control of erosion, and husbandry and breeding of livestock. Participation in community and State citizenship activities and cooperation with State and Federal agencies in management of the land for grazing and other uses must be evaluated.

- 2. AWARDS FOR PROFESSIONAL AND TECHNICAL GUIDANCE: A person or persons with range management or range conservation expertise and education, but not ranch owners or operators, may be selected and honored for their contribution to excellence in grazing management. Such persons may be employees of Federal or State agencies or universities, other government agencies, or individuals operating independently or as members of agricultural firms.
- 3. **OUTSTANDING SERVICE AWARDS**: A person not limited to Society membership, and not limited to residence in Arizona may be nominated for an Outstanding Service Award by any member of the Arizona Section of the Society for Range Management. Such nominations will be made to the Board of Directors prior to the end of the Calendar year.
- 4. **OUTSTANDING YOUNG RANGE PROFESSIONAL AWARD**: This award requires SRM membership and recognizes superior performance and leadership potential in any range-related area. Nominee must be less than 40 years old on January 1, 2003. If you are aware of a young range professional who you feel is deserving of this award please send in your nomination!! This is an excellent opportunity to give a hard-working individual some great recognition.

### **Public Affairs Committee**

A report was developed from the winter meeting in Laughlin, NV, that dealt with recovery of the desert tortoise. The Fish & Wildlife Service has done extensive work and has spent millions of dollars related to the autecology and synecology of the Mojave and Sonoran desert tortoise. The population of the Mojave tortoise continues to decline. Livestock grazing does not seem to be a major factor; instead, predation and disease seem to be the main variables. The Sonoran desert tortoise population seems to be fairly stable in numbers except at one or two locations, but the reason for its decrease at these sites is poorly understood. This report is currently being reviewed by the Nevada Section. After consensus between the Arizona and Nevada Sections it will be forwarded to the UFWS, Arizona Game & Fish Department and Nevada Fish & Game.

# GOVERNOR NAPOLITANO ANNOUNCES FORMATION OF STATE DROUGHT TASK FORCE

Governor Napolitano signed Executive Order 2003-12, establishing the Arizona Drought Task Force, on March 20, 2003. The Governor directed the Department of Water Resources to provide leadership in this effort. The Task Force itself is comprised of state agencies and elected officials; however, representatives of Arizona counties, cities, towns, Indian tribes, water and power utilities and the public are invited to participate.

The Executive Order requires that a short-term drought plan be prepared to respond to potable water needs, as well as non-potable needs for agricultural operations, wildlife and wildfire this summer. The short time frame available to develop this plan requires that we depend heavily on previous drought planning efforts, and that we move quickly to establish priorities and implementation strategies. The Order also requires that a long-term, comprehensive plan be developed that will provide for drought planning efforts throughout the state and a coordinated response framework. This longer-term effort is intended to recognize and build upon existing drought efforts, and reduce the impact of drought on economic activities, communities and habitat throughout the state. The final major assignment is the development of a conservation strategy that focuses on education, technology transfer and assistance.

A working group on Range and Wildlife will be formed to provide input to the Task Force.
